### REPORT FROM THE PASTOR

This is the eighth year we've produced this particular annual report. In late Spring or early Summer we produce an entirely different report. That one focuses on celebrating all the good things God is doing through the programs of the church. This report, however, is designed to give a snapshot of systems which undergird those programs. In the other one we'll focus on the ministry areas: Worship, Hospitality, Mission and Service, Discipleship, Communication

### NOMINATING COMMITTEE

Now there are varieties of gifts, but the same Spirit; and there are varieties of services, but the same Lord; and there are varieties of activities, but it is the same God who activates all of them in everyone. We are called into the church of Jesus Christ by baptism. We are marked as Christ's own by the Holy Spirit. The common calling of all Christians is to be disciples and servants of our Lord. Within the community of the church, some people are called to particular service. 
### PERSONNEL COMMITTEE

Here are some of the highlights from 2023:

- 1. Rebecca was hired as MPVC's Associate Pastor for Discipleship.
- 2. Joshua Verhalen (Our Director of Music Ministries) got married this year! We celebrated with him and got a gift for him and his wife on behalf of the church.
- 3. Pastor Dan was able to take a 3 month Sabbatical over the summer and the Personnel committee facilitated the ministry of Linda Stewart-Kalen as "Sabbatical Pastor" while he was gone.
- 4. Barbara Koozer continued to serve faithfully as MVPC's Ministry Facilitator and Office Coordinator.
- 5. Additional nursery workers were hired throughout the year.
- 6. A 3.2 percent cost of living wage increase was recommended to and accepted by the session.
- 7. Dan's term of call were approved for 2024.

### ENDOWMENT COMMITTEE

The Endowment Committee is comprised of: President, Bill DeHon Secretary, Bob Wygal, Vice President, David Gale, Member at Large, Sandy Ball Treasurer, Kitty Willis

The MVPC Endowment was created and exists solely for charitable purposes with its objectives being: the promotion and development of religious, charitable, and educational activities, and expenditures related to the maintenance and purchase of church property. The Committee to oversee and manage the Endowment Fund was established in 2013 under the authority of MVPC's Session.

In 2023 donations to the Endowment Fund were \$12,225.73 bringing total donations to the endowment from inception to \$164,484. The total value of the fund on December 31, 2023, including results from investments, is \$231,045.

All money contributed to the MVPC Endowment will be held in perpetuity with proceeds, as determined by the Endowment Committee, to be used to benefit MVPC, its people and programs according to Session's priorities.

The Endowment Committee is also the steward for the remainder of Julia Gray Cook's estate. In June, \$268,651 was received, closing out the charitable remainder trust Ms. Cook established before her death in the mid 1980's. Of that amount, \$263,598 has been retained as endowed funds to generate future income. The total value of the fund on December 31,2023, including results from investments, is \$286,336. (cont.)

### ENDOWMENT (cont.)

The money generated by the Julia Gray Cook (JGC) Endowment will be used for gifts to families in need and the elderly in Skagit County and Non-profit agencies in Skagit County that provide for those populations. Monies for both the Endowment Fund and the Julia Gray Cook Fund are currently kept in Banner Bank and Vanguard. If you are interested in exploring a means of charitable tax-advantaged giving, please seek out an endowment committee member or talk with your tax advisor.

Patti Allen and Ward Ernst lead the Hospitality Team arranging beautiful events so members of our congregation and the community can break bread together, and there are so many more who give their time in big and small ways! Thank you to everyone who helps MVPC be a cornerstone of this community.

At the beginning of the Stewardship season, the Committee revisited campaigns in the past and thought about how to invite the congregation to give faithfully and generosity moving forward. Several members and friends of MVPC were asked to share their stories about why they pledge and give to the church. So much love and inspiration was shared with the congregation during this campaign both in person and our newsletter.

The 2024 Stewardship campaign was a great success. For comparison, in 2023, 59 Pledge cards were received by the church for a total amount pledged of \$276,992. In 2024, however, we received 64 Pledge cards for a total amount pledged of \$313,890. Thank you to everyone who submitted their Pledge cards as our church continues to grow.

As our Forward to a Bright Future Capital Campaign draws to a close and we approach paying off the mortgage, we reflect back and give thanks to God. This congregation has taken a tremendous step by not only completing a multi-phase and comprehensive remodel that impacts each of the groups who use our building, but also paying for it in just a few short years.

It's no doubt that the generosity of MVPC shines through in all we do. As the Stewardship team we give thanks for God's faithfulness, and for yours!

## <u>FINANCE</u>

2023 was a year that MVPC was in full activity mode across the board. Our ministry, mission, small-groups and open community organizations are back to actively using our facility throughout the year. God's work is truly in action among us.

We balanced our way through the year between operating with a planned deficit while experiencing, once again, the effects of increasing costs for everything. As always, it is through dedicated and caring members and friends of MVPC and their generous pledges and donations that the church was able to support its operations, ministries, missions and partners. The generosity of the congregation also allowed us to get very close to paying off the Forward To A Bright Future Capital Campaign, which we expect will be completed in the next few months. This is a major achievement in such a short period of time (within 3+ years).

The following provides you with a summary of major activities, achievements and/or accomplishments within the finance committee and church at large:

A successful and productive review of our financial records was conducted by church members Rosemary Gale and Ron Pinaire.

A successful implementation of a new "card reader" by MomCo Skagit (formerly MOPS) during their garage sale for taking payments that went directly into the on-line donation system.

Paid down the Capital Campaign Mortgage Loan principal from \$600,000 to an end of year balance of \$24,021.

Began the investigation into the possibility of converting from a "server-based" to a "web-based" system to make our financial processes easier and more convenient for our volunteer team.

The financial operations of the church could not function without the all-volunteer help we receive from our Finance Committee (Leslie Braun, Jessica Jasper, Anne Long, Jim Byron, Bruce Lavers and Steve Butt); from David Neal (computer software specialist) and from Brad Clure (computer hardware specialist). They have continued to keep our Church Windows finance system and computers working smoothly.

I would like to recognize and thank the following people for their gracious volunteer work in keeping the books, paying the bills and providing experience and wisdom to the team:

**Leslie Braun** - Financial Secretary - responsible for reconciliation of the bank account, the financial reporting process, and income processing and tracking.

Jessica Jasper – Assistant Financial Secretary

Anne Long - Treasurer - responsible for paying bills and reimbursements and filings for payroll.

Jim Byron – Assistant Treasurer

Laurie Parker - Responsible for Payroll
